#### 1. Introduction

Hengyuan Refining Company Berhad ("HRC") or (the "Company") has adopted this Directors' Fit and Proper Policy ("this Policy") to ensure that each of the directors appointed to serve on the Board of Directors ("Board") are fit and proper, for purposes of carrying out their roles and responsibilities effectively in the best interest of the Company and its stakeholders.

### 2. Objective and Purpose

- 2.1 This Policy serves as a guide for the Company's Board Nominating and Remuneration Committee ("BNRC") and the Board in their review and assessment of potential candidates for appointment as directors, as well as directors who are seeking re-election in the Company.
- 2.2 The fit and proper criteria shall be applicable at all times and all directors of the Company shall act with the highest standard of integrity and professionalism as well as comply with all relevant legal and regulatory obligations.
- 2.3 This Policy is to be considered collectively with the Company's Board Diversity Policy, the assessment of the Board's composition, the requirements of the Bursa Malaysia Securities Berhad's Main Market Listing Requirements ("MMLR") and other applicable laws and regulations, and any other factors determined by the BNRC and the Board for the appointment and re-election of directors for the Company.

# 3. Fit and Proper Criteria

In assessing whether a director is fit and proper, the BNRC and Board shall be guided by the following criteria, which is non-exhaustive, and declarations by each individual candidate or director:

# 3.1 Character and integrity

#### 3.1.1 Probity

- is compliant with legal obligations, regulatory requirements and professional standards.
- has not been obstructive, misleading or untruthful in dealings with regulatory bodies or a court of law.

#### 3.1.2 Personal Integrity

- Has not perpetrated or participated in any business practices which are deceitful, oppressive, improper (whether unlawful or not), or which otherwise reflect discredit on his professional conduct. Improper practices may include but is not limited to practices that are corrupt, unethical, immoral, indecent, dishonest, harmful to others, or practices which will attract a negative perception to a person, business or company.
- Has not had any service contract (i.e. in the capacity of management or director) terminated in the past due to concerns on personal integrity.
- Has not used his/her position as political appointee or authority to secure, obtain or enjoy benefits in a manner that contravenes the principles of good governance.

#### 3.1.3 Financial Integrity

- Manages personal debts or financial affairs satisfactorily and with good financial standing.
- Demonstrates the ability to fulfil personal financial obligations as and when they fall due.

#### 3.1.4 Reputation

- Is of good repute in the financial and business community.
- Has not been the subject of civil or criminal proceedings or enforcement action, in relation to managing or governing an entity for the past 10 years.
- Has not been substantially involved in the management of a business or company which has failed (including a GN3 or PN17 company), where that failure has been occasioned in part by deficiencies in that management.

# 3.2 Experience and Competence

#### 3.2.1 Qualifications, training, skills and knowledge

- Possesses education and qualification that is relevant to the skill set that the director is earmarked to bring to bear onto the boardroom (i.e. a match to the board skill set matrix).
- Has a considerable understanding on the workings of a corporation.
- Possesses general management skills as well as understanding of corporate governance and sustainability issues.
- Keeps knowledge current based on continuous professional development.
- Possesses leadership capabilities and a high level of emotional intelligence.
- Possesses professionalism.

# 3.2.2 Relevant experience and expertise

 Possesses relevant experience and expertise with due consideration given to past length of service, nature and size of business, responsibilities held, number of subordinates as well as reporting lines and delegated authorities.

# 3.2.3 Relevant past performance or track record

- Have had or is currently in a career of a senior management or occupying a high-level position in a comparable organization for at least 5 years.
- Was accountable for driving or leading the organization's governance, business performance or operations.
- Possesses commendable past performance record as gathered from the results of the board effectiveness evaluation.

# 3.3 Time and Commitment

### 3.3.1 Ability to discharge role having regard to other commitments

 Able to devote time as a board member, having factored other outside obligations including concurrent board positions held by the director across listed issuers, taking consideration his board attendance records, and non-listed entities (including not-for-profit organisations).

- 3.3.2 Participation and contribution in the board or track record (applicable for re-election of existing directors only)
  - Demonstrates willingness to participate actively in board activities.
  - Demonstrates willingness to devote time and effort to understand the businesses and exemplifies readiness to participate in events outside the boardroom.
  - Manifests passion in the vocation of a director.
  - Exhibits ability to articulate views independently, objectively and constructively.
  - Exhibits open mindedness to the views of others and ability to make considered judgement after hearing the views of others.
  - Demonstrates ability to work cohesively with other members of the Board.
- 3.4 For independent directors meets the requisite criteria of independence set out in Bursa Malaysia Securities Berhad's MMLR.
- 3.5 Any other criteria that the BNRC and the Board may determine from time to time.
- 3.6 The Director's Fit and Proper Declaration Form set out in Appendix I (or such other form as the BNRC may determine from time to time) shall be completed by a person who has been identified for appointment as a director or for re-election/reappointment as a director.

### 4. Review of Policy

The BNRC shall periodically assess and review the effectiveness of this Policy and its compliance with applicable laws and regulations, as well as the best practices under the Malaysian Code on Corporate Governance, and make recommended changes to the Board (for approval) as it deems fit or necessary.
